## **IMPLEMENTATION OF LIVESTOCK SUPPORT PLAN NEARLY €180 MILLION ANNOUNCED BY LE FO**

### **IN SOCIAL TAX CUTS MADE BEFORE END 2015**

**USPA NEWS** - Thanks to strong mobilisation of the MSA, services of the State, and agricultural organisations, farmers will benefit by the end of the year of very important social contributions relief pursuant livestock Support Plan announced by the Prime Minister on September 3, after the summer's farmer crisis.

- The decrease in the minimum base disease by 2015 will be directly integrated by the MSA in the calculation of the final call 2015 contributions sent by the end of November without any further farmers. This measure represents a decrease of expenses of € 45 million in 2015 for all farmers (down minimum dues disease € 833 to € 454) and € 65 million in 2016 with the complete removal of the minimum tax base disease carried by the Government to Parliament in the LFSS 2016

-The measure allows farmers to opt derogation for calculating contributions in 2015 for a contribution base corresponding to earnings in 2014 (instead of the three-year base common law) will also be integrated directly into the final appeal contributions sent by the end of November by the MSA funds. This measure affects all farmers who have requested and meeting the eligibility criteria (income less than € 4,184 in 2014, or 11% of the social security ceiling). This measure represents a potential reduction of social charges of € 87 million, including € 46 million for the benefit of farmers;

- The absorptions social contributions to breeders, amounting to € 50 million, will be performed by the MSA by the end of the year and will be the subject of information to farmers in December for all cases investigated by then in emergency cells. This represents potentially more than 75% of the additional envelope on 3 September.-----
